Before registering with Wordlex, the company administration strongly recommends that you read the document below.

It describes all the basic rules, binding on both parties, rights and obligations, as well as the conditions for the client's interaction with the investment project of Wordlex.

Register in the Wordlex project only if you unconditionally accept all the provisions described below.

- Client is a person who fully agreed with the terms of the current agreement, timely registered on the Wordlex website.

- Project is a web resource located at <https://wordlex.online>



1. All individuals who do not belong to the following categories have the right to create an account within the Wordlex investment project:

1.1. Minors (in accordance with the legislation of the country of residence);

1.2. Persons recognized as legally incompetent on the basis of a medical opinion;

1.3. The decision to join the Wordlex project, all operations in the project (compliance / non-compliance with the rules, financial transactions, etc.) and the consequences are the responsibility of the customer.

Rights and obligations of the client of the Wordlex project:

1.4 Each client of the project, equally with other similar clients, has the right to use all the services provided to him by the Wordlex project: use a personal account on the project website, invest funds and receive income according to the terms of the investment plan, use the bonuses of the project's referral program, contact project support service.

1.5. The client has the right to create and manage accounts within the project.

If the project administration establishes the client managing several accounts linked by the referral program, all his accounts will be immediately blocked, and the available funds will go to the company as payment of moral damages for fraud against it.

1.6. The client undertakes to ensure complete confidentiality of any information received from the company administration.



1.7. The client undertakes not to disclose his registration data to third party.

if the client provided his access password to third parties, what subsequently led to the hacking of the account and the loss of funds, the responsibility is only his.

- The client undertakes to provide reliable protection for his computer, tablet, smartphone and any other device from which he accesses his account. If funds are stolen from a client due to lack of adequate protection, Wordlex is not responsible for this.

- The client independently decides on the choice of an investment plan, the amount invested in the project and realizes that any investment is associated with certain risks, and therefore, for any result, he will not make claims to Wordlex

- The client is advised to periodically access his account during the period of the investment plan to monitor the security of his account. In case you find traces of unauthorized access to your account, financial transactions carried out without your knowledge, etc. contact the company support immediately or directly to the administration.

- The client is obliged to comply with the established rules, regulations and recommendations for depositing and withdrawing funds, which are described in his personal account. In case of non-compliance with these conditions, the Client has no right to make claims and demand material compensation from Wordlex, if, due to these conditions, the result of the client's participation in the project does not correspond to the expected result.



2. The client is obliged to comply with the established rules in full. In case of violation of any of this document's provisions, Wordlex has the right to terminate cooperation with this client unilaterally.

3. Wordlex guarantees its clients the provision of all declared services in full and in accordance with the specified conditions.

4. Wordlex undertakes to ensure the operability of its investment project, provide consulting support to the project's clients, and promptly eliminate any technical problems that caused difficulties for the client to work with the project's website.

5. Wordlex guarantees its customers the maximum level of protection of their personal data and investment funds.

6. Wordlex undertakes to ensure complete confidentiality of the client's personal information received during registration, as well as for the entire period of the client's participation in the project.

7. In case of revealing the facts of fraud on the part of the client (attempts to hack the accounts of other clients, representing oneself as a Wordlex employee to attract new customers through a referral program, etc.) or violation of any of the paragraphs of this document, the Wordlex administration has every right to unilaterally terminate the provision of investment services to this client, block his accounts without the possibility of returning the money he has on it funds.
